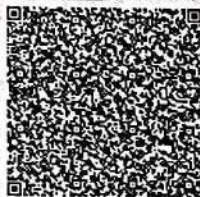

AND WHEREAS THE SETTLOR above named has settled a sum of Rs. 11000/- (Rupees Eleven Thousand Only) as a Fund.

AND WHEREAS THE TRUSTEES named are willing to accept the office of the Trustees for the purpose of carrying out the wishes of the SETTLOR of the Trust under the Provisions and directions set forth herein, so as to enable to pursue its vowed objects.

THIS INDENTURE WITNESSETH AS FOLLOWS

1. That SETTLOR above named hereby establishes a Charitable Trust by the name of "BHAWANA EDUCATIONAL TRUST" for the purpose and upon the conditions set forth hereunder.
2. The TRUSTEES named above shall be the first trustees and have given their consent to be appointed as the trustees and as token thereof, they have set their hands to this Instrument.
3. The office of the Trust shall be at 91 MOHALLA MATAWALA, PARIKSHITGARH MEERUT UTTAR PRADESH-250406 and/or at such other place or places as the trustees may decide from time to time.
4. That, in order to effectuate his aforesaid desire, the settlor has set apart and handed over to the trustees, a sum of Rs. 11,000 (hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.
5. That the objects for which this trust is established are:
 - I. Establish a non-profit oriented charitable institution which is a Trust to providing Educational Activities to upliftment the livelihoods of Society.
 - II. Establish a non-profit oriented charitable institution which is a Trust of nature lovers who live in harmony with nature and seek to protect and preserve the diversity of natural resources and a healthy environment.
 - III. To contribute efforts towards sustainable development through participation, advocacy, demonstration projects, monitoring and research, as well as cooperation and networking with other NGOs and government departments

- IV. To raise awareness on environmental issues and push for changes in policy and development strategies
- V. To organize various activities in the field of Medical Care, Medical Research, Health Education.
- VI. For environmental monitoring; promoting environmental education, conducts seminars and workshops, training and capacity-building; implementing demonstration projects; conducting advocacy work in partnership with the government; and the promotion of regional and international cooperation on the environment.
- VII. Work concurrently on environment and development, for acknowledging the fact that environmental problems are embedded in economic and social systems
- VIII. To promote a healthy relationship among individuals who are actively engaged in environmental related issues through useful interaction, organizing regular meetings and social activities.
- IX. To set up educational institutions and other institutions which are offering various courses in environmental and yoga related subjects and get affiliation/approval from university/universities or other institutions for conducting such courses and facilitating Researchers, Students from Foreign Universities.
- X. To institute awards, prizes and gifts for encouraging protection of the environment.
- XI. To establish a printing and publishing house or otherwise bring out periodicals, magazines and books, e-resources and study of data, statistics, laws, news and views on life issues in respect of the environment, natural resources and natural phenomena.
- XII. To establish a multimedia centre which broadcast environmental protection and sustainable development related materials on both online and mainstream media.
- XIII. To consolidate Environmental journalists, experts, environmentalists, on one platform to bring their broad assessments on key environmental issues to create maximum public awareness to achieve maximum active community participation in environmental protection.
- XIV. Survey the diversity of flora and fauna around us and draw special attention to the aesthetic, economic, scientific and conservational aspects.
- XV. To get involved in the practical management of conservation and regeneration of traditionally used indigenous species to reduce pressure on the natural habitat of our ecosystem.

- XVI. Keep a constant vigil on the habitats of plant and animal forms around, quality of air, water, noise levels etc; preserve on natural resources, watersheds and ecosystems, and urge the authorities to take remedial measures in cases of lapses or over-exploitation
- XVII. Initiate steps to preserve Ethnic Culture and Heritage and to disseminate expertise, knowledge and information relating to every aspect of Nature and History to those who need them.
- XVIII. Acquire information on nature-friendly technologies and take initiatives to popularize them.
- XIX. Create awareness among the public about the need to reduce wastage of water, fuel and other natural resources and usage of various renewable resources such as solar energy, Wind energy, Biogas etc.
- XX. Research and find permanent sustainable waste management solutions to reduce the health hazard and sanitation problems caused by bio- degradable wastes and non-degradable dry wastes. Plan and implement a concerted public awareness campaign on households regarding scientific and effective segregating method of wet and dry garbage.
- XXI. To Promote and support 'Swacch Bharat Abhiyan' Programs.
- XXII. Conduct seminars, studies, research on urban pollution, water pollution and flood management.
- XXIII. Enlighten the public about the rights, responsibilities and laws for maintaining a sustainable environment by arranging exhibitions, awareness campaigns etc.
- XXIV. Work in close liaison with other Associations having similar objectives and with local bodies State Governments, Central Government and The United Nations Environment Programs (UNEP) for the sustainable environment and also become the part of Environmental impact Assessment programs.
- XXV. Support grassroots groups and undertakes public interest litigation and advocacy works
- XXVI. To engage charitable and social service activities of every kind to help the poor, needy, aged, ill, backward and weaker sections of the general public without the discrimination of religion or caste or creed of sex.
- XXVII. Support and provide Tribes (giving proper orientation in Forest protection in a broad way)
- XXVIII. To conduct international level Environmental campaigns, whilst giving priority to developing linkages with local NGOs, research institutes, universities and government departments.

- XXIX. To purchase, construct, taken on lease or otherwise acquire land, building and other movable and immovable properties and to sell, lease, mortgage or hypothecate or otherwise dispose of all or any of the property and assets of the trust on such terms and conditions as the trust may deem fit for attaining the objects.
- XXX. To accept donations in cash or in kind, grants and collect subscriptions, fees and other charges for the services rendered by the trust and take and raise funds by way of loans or otherwise and the receipts shall be solely utilized and applied towards promotion of its aim and objects of the trust.
- XXXI. To do all other lawful acts, as are necessary for and/or incidental to the attainment of the aims and objects of the trust.
- XXXII. To promote community or individual action and campaign for greater accountability on the part of the government and corporate sector.
- XXXIII. To strengthen Internet and World Wide Web capacities for taking full advantage of the growing information technology which provides tantamount opportunities not only for networking both nationwide and worldwide but also for strengthening the capacities of major groups, especially NGOs related to Environmental and Social aspects.
- (a) To promote, establish, support, maintain run, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centers and/or such other similar charitable institutions in India for the benefit and use of the general public.
- (b) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research, Sports Center and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, color, race, creed or sex.
- (d) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, Sports, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.
- (e) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharmshalas and rest houses, for use by public in general.

- (f) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
 - (g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
 - (h) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
 - (i) To build awareness of business innovations as well as social awareness that accelerate women's empowerment and have a real impact on the quality of life for women, and their families and communities.
 - (j) To promote, organize, encourage study and enhance knowledge, understanding and appreciation of nature, and the principle and practice of conservation of natural resources among the common mass. To promote and maintain liaison between various disciplines of science and technology related to environment and grant aid or render assistance to other public charitable trusts or institutions.
4. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
 5. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 hereinabove.
 6. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.
 7. That for the furtherance of the objects of the trust, the trustees shall have the following powers:
 - (a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.
 - (b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
 - (c) To convert and deal with the trust property and/or any investments for the time being.

- (d) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.
- (e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- (f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (g) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (h) To open account in the name of the Trust, Trustees and/or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- (j) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- (k) To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- (l) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- (m) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

- (n) To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the Trust.
- (o) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- (p) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, Organization or Trustees to start maintain, or carry out such charitable objects.
- (q) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (r) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (s) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- (t) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.
- (u) To establish, promote, manage, organize or maintain or to assist in establishing, promoting, managing, organizing, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.

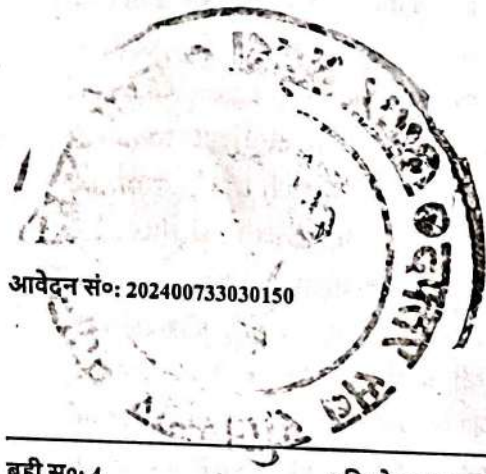
- (v) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
 - (w) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
 - (x) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorized to amalgamate.
 - (y) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organization on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organization with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust thereof relating to Trust Funds so transferred.
8. The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omissions or commissions of the other trustees, nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
9. The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
10. The number of the Trustees shall not be less than two and more than four. If the number of the trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.
11. The managing trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being considered proper. A person shall cease to be a Trustee either:
- (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or

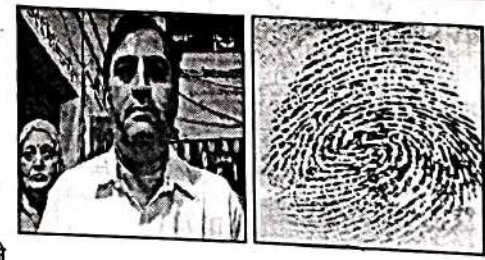

- (ii) If he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees
12. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
13. The Trustees may from time-to-time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations: -
- (a) Two Trustees shall form a quorum for a meeting of the Trustees.
- (b) All matters will be decided mutually by the Trustees.
- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
14. The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
15. The accounting year of the Trust shall be the financial year ending on 31st March every year. The Trustees shall maintain True & Correct Accounts of all Receipts & Payments and dealing in this regard to the Trust Property. Books of Accounts shall be audited every year by a **Qualified Chartered Accountant** Appointed by the Board of Trustees
16. **Irrevocability Clause:** - The Trust and the Trust funds shall be and irrevocable for all times.
17. The office of the Trust shall be situated at Uttar Pradesh unless changed by the Trustees by two thirds majority.
18. **Investment Clause:** The funds of the Trust shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income tax ACT 1961 AS amended from time to time.

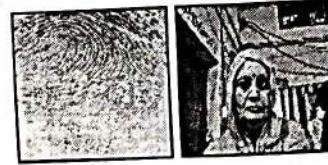
